

Terms & Conditions

1. Period of engagement

The engagement shall be initially for a period up to 1(one) year which may be extended/curtailed depending upon the performance of the Consultant or functional requirement of the office.

>> **No Extension will be granted beyond the age of 65 years.**

2. Selection Procedure

The engagement will be purely on contract basis. Application received in response of this advertisement will be shortlisted on the basis of experience and qualification of applicants. Consultants will be selected from shortlisted candidates.

>> **CBC reserves the right to reject any application without mentioning any reason.**

3. Remuneration

A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement.

OR

In case of the Central Government retirees under NPS, an amount equivalent to 30% of the last basic pay as drawn at the time of retirement shall be deducted from the last basic pay and the resultant amount shall be the fixed monthly amount as remuneration.

OR

The retired employees of non-pensionable Statuary Bodies / Organizations / Public Sector Undertakings would be paid a fixed remuneration of Rs. 60,000/- Per Month.

The amount of the remuneration so fixed shall remain unchanged for the term of contract and there will be no annual increment/ percentage increase during the contract period. No DA/HRA, residential accommodation shall be admissible.

4. Transport Allowance

An appropriate and fixed amount as Transport Allowance for the [purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.

No TA/DA is admissible for joining the assignment or on its completion. However, they will be entitled to draw TA/DA as per normal rules as applicable to any serving Officer of an equivalent rank in CBC whenever they are required to travel outside Delhi in connection with the work of the Commission.

5. Leave

The Consultant will be entitled for the paid leave at the rate of 1.5 days for each complete month of service. Accumulation of leave beyond calendar year may not be allowed. In special circumstances, the Consultant could be called for services on holidays or beyond normal working hours for which no extra remuneration will be paid. However, for attending office on Saturday's/ Sundays/ Other Gazette holidays they may be given compensatory off.

6. **Scope of Duties**

During the period of such engagement, the Consultant would be required to perform the duties of a dealing hand. He will report to US depending upon the task assigned by the officer concerned.

7. **Tax deduction at Source**

The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment for which the office will issue TDS certificate.

8. **Office time and working hours**

Engagement of Consultants would be on full time basis. Working hours shall be from 9.30 AM to 6.00 PM during working days including half an hour lunch break in between. They will not be allowed to take any other assignment during the period of contractual engagement. The Consultants may be called for duty on Saturday/Sunday/other Gazetted holidays, if required.

>> The consultant will be required to mark his/her attendance in Bio-metric System or In the attendance register

9. **Confidentiality of data and documents**

i. The intellectual Property Rights (IPR) of the data collected as well as the deliverables produced for the office shall remain with this office. No one shall utilize or publish or disclose or part with, to a third party, any part of the data or statistics or proceedings or information collected for the purpose of this assignment or during the course of the assignment for the office, without the express written consent of the office. The Consultant shall be bound to hand over the entire set of records of assignment to the office before the expiry of the contract, and before the final payment is released by the office.

ii. The Consultant would be required to sign a non-disclosure undertaking as per **Annexure III**.

10. **Conflict of interest**

The Consultant appointed by this office, shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of this office. No Consultant would be permitted to take up any other assignment during the period of Consultancy.

11. **Termination of service**

The engagement may be terminated at any time by the office without assigning any reasons by giving a notice of 07 days. In case, a Consultant desires to leave the assignment, he/she is to give 07 days' notice which can be curtailed/extended depending upon the workload.

>> In the event any Consultant is found unfit on any account or if he/she is found guilty of any insubordination/misconduct, his/her services can be terminated immediately without any notice.

12. CBC shall not be responsible for any loss, accident, damage; injury suffered by the Consultant whatsoever arising in or out of the execution of his work including travel.



13. Guidelines for the submission of the application
