### 1. Introduction

### 1.1. Approach & Methodology for the Capacity Building Plan

As discussed in previous reports, the main purpose of the study is to improve the productivity and efficiency of government employees through interventions across various spheres: Institutional level, Organizational level and Individual level. This chapter basically focuses on the "Individual level". As part of this, we have identified "competency requirements" required across different divisions. Based on that, the consultant has tried mapping "competency gaps" and thus provided a suggestive list of trainings and courses.

The figure below details out the approach undertaken for the exercise. As depicted, the consultant undertook as – is – analysis, based on secondary research and certain official documents on the organizational structure provided by the department.



#### Figure 1: Overall approach for the exercise


Post that, consultant undertook individual consultations across various officer levels (for Undersecretary (ies) and officers below, the personal interactions were coupled with a google form survey to have a wider coverage). The stakeholder consultations were primarily a two – staged process. In the first stage, the consultant understood the "competency requirements" and "training needs". While, in the second stage, the consultant presented the identified "competency gaps" for validation, presented and discussed the "suggested list of trainings".

In the first stage, the consultant started with consultations with Directors and Deputy Secretary (ies) as they are heading respective divisions, and thus would have in – depth understanding across facets. Further, the consultant held a mix of focused group discussions and individual consultations based on the availability of officers for Under – secretary(ies), Section officer (s) and Assistant section officer(s). This was also coupled with consolidating findings from the google form survey conducted, capturing inputs of Under – Secretary(ies), Section officer (s). With the compilation of inputs from these officers, the consultant held consultations with Joint – secretary (ies) and Additional Secretary(ies), heads for identification of gaps as well as validation of the gaps and interventions suggested across the process. The figure below details out the first stage of the consultation process.









After the first round of consultations, the consultant prepared the list of proposed interventions, bifurcating it into training and non – training interventions. While the training interventions contained the list of online and offline trainings across different aspects; the non – training interventions include division – wise identification of immersion trainings / exposure visits. As per CBC's directions, for identification of courses, the consultant prioritized courses available on iGOT and ISTM platform, further searched for relevant trainings available with domestic institutes and then foreign institutes.

As the next step, the consultant held the second round of focused group discussions, headed by Joint Secretary(ies) / Additional Secretary(ies), including Director(s) and Deputy Secretary(ies) under respective sections/ divisions. The consultant showcased the suggested list of trainings, sought feedback and also incorporated the courses suggested by them in the calendar plan. Post that, the consultant requested for a Director/ Deputy Secretary to be nominated as single "point of contact" for providing support to consolidate the indicative number of officers who can be targeted for the given set of trainings.

As a final deliverable, the consultant prepared the Training Calendar as a part of the Annual Capacity Building Plan focusing on interventions at the "Individual level". The training calendar has detailed information about each training course, such as course details, institute, duration, cost etc. For every course, the consultant mapped the target audience officers' level who are suggested to undertake the training) and indicative number of personnel who have shown interest in undertaking the course / training. As part of providing implementation support, the consultant has also provided the Training Calendar for the first quarter, coupled with several exposure visits across various divisions of the department.

### 2. Competencies Identified and Capacity Building Interventions Suggested: <u>Division-Agnostic</u>

At individual level, for DoC, a set of functional and behavioral skills required among officers across various divisions were cutting – across each other. Hence, the consultant has prepared a consolidated section encompassing the division – agnostic set of functional and behavioral competencies. This section provides a list of functional and Behavioral competencies required to complement the domain knowledge and technical know – how (division specific domain and functional competencies are discussed in the next section).





In this section, competency assessment is thus carried out across two categories:

- 1. **Behavioral competency:** This includes competencies related to behavior and soft skills such as negotiation skills, self-motivation, interpersonal skills, etc. One of the important competencies under this segment is the citizen centricity/ stakeholder focus capability.
- 2. **Functional competency:** This includes competencies related to the functional aspects of the division such as science of policy designing and implementation, project management, financial planning, etc. and most importantly, technological know-how

These competencies include combination of theoretical and practical knowledge, cognitive skills, adoption of technology and automation, values, and behavior to improve performance. These competencies and suggested trainings have been identified basis the three – lenses: National priorities, citizen centricity, and Emerging technologies.

The table below illustrates the behavioral and functional competency requirements across all divisions of the Department.

As can be seen from the table above, communication skills, especially for coordination and negotiation emerge as crucial skill – set. The functional competencies are wide ranging from data management, administration to legal jargons and terminologies.





Based on the identified competency assessment, the consultant has undertaken a detailed analysis to identify the division-agnostic trainings/ courses. The table below provides a brief information of the course along with trivial details such as duration, target group and knowledge partner.

For functional competencies, the trainings proposed are primarily across the following domains: MS office, Procurement and contract management, General financial rules, Cyber security, office procedures, vigilance matters and project management.

In the similar way, the trainings proposed for behavioral competencies are: Effective communication, leadership, team management, stress management and decision making.

### 3.1. Trade Intelligence and Analytics Wing

The focus of this section is to concentrate on DoC's analytics requirements and providing knowledge support to trade functions; internal division within the department to maintain control over data quality and distribute necessary statistics to other wings.


