However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

3. Service & Support

4. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

5. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

6. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

9. Buyer Added Bid Specific ATC

- (i) If a seller reduces their price or offers the contracted goods to any other person or organization at a lower rate during the contract period, the contract price is automatically reduced to match the lower p rice for all subsequent supplies
- (ii) Bid Security Declaration, signed by the bidders accepting that if they withdraw or modify their bids during the period of validity, etc., they will be suspended for the time specified in the Tender Documen t.
- (iii) Delay in submission of deliverables as per agreed timelines and non compliance of any of the term s and conditions shall lead to penalty upto 10% of the total contract value.
- (iv) The buyer added terms and conditions are in addition to all the applicable terms and conditions of GeM.

The Consultant hereby agrees, undertakes and covenants to treat the Confidential Information entrusted to it with absolute and utmost caution and to use all due care as would normally be exercised with its own material. The Confidential Information will be used solely for the purpose of this Contract and will not be u sed in any way directly or indirectly that is detrimental to CBC or its affiliates and such Confidential Information will be kept strictly confidential by Consultant and will not be disclosed, shared, leaked or disseminated to any third person in any manner whatsoever, except that Consultant may disclose the Confidential Information or portions thereof to those of its Personnel who need to know such information on a "need to know" basis, with prior approval of the CBC (it being agreed that those Personnel will be informed of the confidential Information and will agree to be bound by this Contract).

During the Term and thereafter, the Consultant will not divulge or appropriate to its own use or to the use of others, any secret or confidential information or knowledge pertaining to the activities of the CBC or of a ny of its subsidiaries, which is provided as confidential to the Consultant. The Consultant shall not publicly disparage the CBC or its work. This clause will survive the expiry or conclusion of this contract.
