Document Lifecycle Workflow The document management system will support a complete lifecycle workflow, covering drafting, review, approval, publishing, and archival. Each document will be routed for approval to the respective Pillar Head before finalization.</li><li>2. Microsoft Copilot Integration for External Resource Repository Microsoft Copilot integration will include access to an external resource repository.</li></ol>	<ol style="list-style-type: none"><li>1. The understanding is correct. The previous versions of the document will be archived.</li><li>2. There would be two repositories;<ol style="list-style-type: none"><li>a. CBC Approved Documents, which would be final knowledge base of CBC.</li></ol></li></ol>

	<p>These resources may consist of documents issued by other government bodies or authorities, which are already approved by their respective competent bodies. Such documents will be referenced or accessed as external documents within the system.</p> <p>3. Deployment and Implementation The solution will be deployed on the CBC premises. The respective CBC team will be responsible for coordination and implementation activities, in collaboration with the selected bidder.</p> <p>4. HR Management System (e-HRMS) Integration The HR Management System will be used exclusively by non-government officials. As confirmed, there will be no integration required with the government e-HRMS portal.</p>	<p>b. External Resource - In this repository people would keep documents sourced from other ministries /organisations. The AI integration should be as such that when given a prompt only for Repository 1, it should provide intelligent answers and when asked from Repository 2, it should provide intelligent answers from whatever document is stored in that repository. Also, if both, internal and external repository selected, AI should intelligently answer the query.</p> <p>3. The selected agency would be responsible for delivering project based on scope of work. CBC will share necessary inputs on request with respect to scope of work.</p> <p>4. The understanding is correct.</p>
